Motion by Besch and 2^{nd} by Tjarks to approve the appointment of Dr. Jeffrey Doolittle to replace Dr. Bottjen on the Board of Health. This term will expire on December 31, 2014. Motion carried.

Motion by McGregor and $2^{\rm nd}$ by Wymore to approve the applications for exemption from buffer strip ban in drainage district facilities on file in the Kossuth County Auditor's Office. Motion carried.

Motion by Tjarks and 2^{nd} by Wymore to approve the 2013 Homestead and Military Tax Credit Disallowances as presented by the Kossuth County Assessor, Judy Samp. Motion carried.

Motion by McGregor and $2^{\rm nd}$ by Tjarks to approve the Law Enforcement Contracts as presented by Steve Kollasch, Kossuth County Sheriff and to authorize Chairman to sign the contracts as presented. Motion carried.

Motion by McGregor and 2nd by Wymore to approve the request from Kossuth County Sheriff, Steve Kollasch to amend his budget for the Special Response Team (15000) Fund to allow for expenses related to the recent acquisition of a patrol dog as well as any other Special Response Team Equipment. The request is to raise the expenses from \$2000 to \$8000. Motion carried.

Motion by McGregor and 2^{nd} by Besch to approve the purchase of an 8' x 30' Mobile Law/Office as quoted by Satellite Shelters, Inc., Hamel, MN, in the amount of \$31,297.00. Motion carried.

Motion by Tjarks and 2^{nd} by Wymore to award a contract to Blacktop Service Co. & Subsidiaries, Humboldt, IA, for \$286,547.85 to perform Seal Coat Work on the following projects that were let on August 13, 2013, at the Kossuth County Courthouse: MSC-1-13, MSC-2-13, MSC-3-13

and MSC-4-13 and further to approve and authorize the chair of the Board of Supervisors to sign contracts and bonds when the appropriate contract documents are returned to the Kossuth County Engineer. Motion carried 4 to 1 with Besch being the NO Vote.

Motion by McGregor and $2^{\rm nd}$ by Besch that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Iowa Lakes Electric Cooperative, Estherville, IA, to upgrade from existing overhead lines to underground lines. Work will involve boring under $480^{\rm th}$ Street, at 704 $480^{\rm th}$ Street, north to south in the right of way. The work will be in Sections 19 and 30, Grant Township. Permit number 08-39-2013 is on file in the Kossuth County Engineer's Office. Motion carried.

Discussion with Kossuth County Engineer was held followed by Drainage, Discussion with Kossuth County Auditor and Board Discussion and Committee Reports.

Lucas Beenken from ISAC was present to have a discussion with Kossuth County Elected Officials and Department Heads.

On motion adjournment was taken until August 27, 2013.
