Description of the detour route is: Commencing at the junction of US 169 and Kossuth County Road A38, thence west approximately 4.5 miles to Kossuth County Road P-30, then south approximately 2.0 miles to Kossuth County Road A-42, thence east approximately 4.5 miles to US 169.
